

MINUTES OF THE PUBLIC HEARING HELD MONDAY, DECEMBER 23, 2013 AT 7:00 P.M.

IN THE COUNCIL CHAMBERS, CITY HALL

PROPOSED LEVY ORDINANCE WAS PRESENTED AND PUBLIC COMMENT WAS RECEIVED BY THE COUNCIL

Mayor August J. Kellerman called the Public Hearing of the Pinckneyville City Council to order at 7:00 p.m. in the Council Chambers, City Hall. The purpose of the Public Hearing was to discuss the PROPOSED LEVY ORDINANCE AS PRESENTED AND PUBLIC COMMENT AS RECEIVED BY THE COUNCIL. Members present: Commissioners Samuel J. Fulk, Leonard J. Heisner, David M. Stone and Mayor August J. Kellerman. Members absent: Commissioner Kevin B. Hicks, who arrived at 7:05 p.m. Administrative staff present: City Clerk Frances I. Thomas and City Attorney Roger Seibert.

Mayor Kellerman opened the meeting and requested City Attorney Roger Seibert explain the primary reason the City is increasing the pension levy for the Police Department. The levy has increased approximately 14.4% from the previous year. The State of Illinois suggested amount of Tax Levy to arrive at the annual requirements of the fund as prescribed by section 3-125 of the Illinois Pension Code \$204,875.00. The City is proposing a levy of \$199,400.00 for the Pinckneyville Police Pension Fund.

Donald and Jeannie Woodside spoke to the Council questioning if the Council understands how many retired and persons of limited income are living in Pinckneyville. The financial hardship will be felt by many residents in the City who struggle just to pay for their medications and food. Helen Schafer stated her children could lose their homes with such a tax increase. Mr. Seibert explained the increase will be about \$10.00 for a \$30,000 home. The amounts are mandated by the state and the City has no other choice.

- Mr. Woodside stated people will be moving out of Pinckneyville. There will be empty buildings. Low income people can't pay this increase. Commissioner Heisner explained there is no good answer. The average tax increase will be approximately \$10.00. This is just the cities portion of the real estate tax bill.
- Mayor Kellerman explained Perry County has one of the cheapest tax rates of any Southern Illinois counties.
- Helen Schafer stated it is just too much at one time.
- Mr. and Mrs. Woodside suggested lowering the employees wages. City workers just ride around and never get out of trucks. The leaves are just lying in the streets.
- Helen Schafer stated the new hospital is even more trouble. We do not need a new hospital.

No further discussion was heard from the attendees and the public hearing closed at 7:25 p.m.

PURCHASE CHOPPER TYPE PUMP

This pump is needed to better handle the amounts of paper and other solid waste from the Prison's sewer flow. The approximate cost is \$30,000.00.
