

**MINUTES OF A SPECIAL MEETING OF THE PINCKNEYVILLE CITY COUNCIL**

**HELD MONDAY JUNE 7, 2021, AT 9:00 A.M.**

**ROLL CALL**

Mayor Robert L. Spencer called the special meeting of the Pinckneyville City Council to order at 9:00 a.m. in the Council Chambers, City Hall. Members present: Commissioners Ricky J. **RESOLUTION NO. R-2021-28, AUTHORIZING THE CITY OF PINCKNEYVILLE, PERRY COUNTY, ILLINOIS, TO ENTER INTO A CERTIFIED WATER/WASTEWATER OPERATOR SERVICES AGREEMENT WITH HMG INFRASTRUCTURE SERVICES, LLC.**

Mayor Spencer introduced Resolution No. R-2021-28, a resolution to be placed on file, authorizing the City of Pinckneyville, Perry County, Illinois to enter into a Certified Water/Wastewater Operator Services Agreement with HMG Infrastructure Services, LLC.
